

### List of Roles Requiring an Enhanced Disclosure

This list has been produced on a common understanding of roles within the Church of Ireland. However, roles may differ in various contexts.

For example, a caretaker in one parish may not be involved in regulated activity with children and therefore, wouldn't require an Enhanced Check, while in another parish, a caretaker might lead a gardening group with children and would therefore require an Enhanced Check. It is important that each role is assessed according to the guidance provided by AccessNI to determine whether an AccessNI check is necessary.

#### List of Roles eligible for an AccessNI Basic Check

- Adult diocesan panel members who do not hear allegations directly from vulnerable adults
- Diocesan Pastoral Assistant (care home)
- Diocesan Support Team
- Organist (who is not leading a choir)
- Parish and Cathedral Events Assistant/Tour Guides/Workshop Facilitator not involving children or exclusively for vulnerable adults
- Trainers who are not working exclusively with children and young people
- Compliance Officer
- Church Warden
- Parish Panel members who do not hear allegations from children
- Pastoral care worker not exclusively with vulnerable adults
- Sexton/Caretaker
- Warm Church Worker
- Workers in residential centres who do not engage with young people (for example who carry out tasks relating to cleaning and catering etc)
