

## List of Roles Requiring a Garda Vetting Check in Dioceses and Parishes

This list has been produced on a common understanding of roles within the Church of Ireland. However, roles may differ in various contexts.

For example, a caretaker in one parish may not be involved in regulated activity with children and therefore, wouldn't require a vetting check, while in another parish, a caretaker might lead a gardening group with children and would therefore require a vetting check. It is important that each role is assessed according to the guidance provided by Garda Vetting Bureau to determine whether a vetting check is necessary.

#### **List of Roles that do not require vetting for Parishes**

- Bell ringer class leaders who do not have supervision duties with children or teaching vulnerable adults
- Bell ringers with no supervision of children or vulnerable adults
- Café staff (some parishes have community coffee shops)
- Camera person/ videographer
- Car park attendant
- Caretaker



- Choir leaders in a choir which does not have supervision duties with children or teaching vulnerable adults
- Choir member with no supervision of children or teaching vulnerable adults
- Church/Glebe/People's/Rector's warden **with no** supervision of children
- CIYD staff who are not involved in working directly with children or dealing with safeguarding issues
- Diocesan support team member
- Education staff in cathedrals who do not engage or work directly with children or vulnerable adults or dealing with safeguarding issues
- Gardener
- Gravedigger
- Organist and assistance organist (with no responsibility for teaching music to children/vulnerable adults or supervising children's/vulnerable adults choir)
- Parish cleaner
- Parish committee members (not involved with safeguarding) e.g. finance committee member
- Parish community worker with no supervision of children or providing recreational activities to vulnerable adults
- Parish events assistant/workshop facilitator on a non-regular basis
- Parish/ Bishop's secretary
- Photographer for children engaged on a non-regular basis
- Safeguarding trainer not working exclusively with children
- Select vestry member
- Theatre group member (unless involving supervision of children's theatre group)
- Volunteer at baby changing and feeding facility with no supervision of children
- Welcome team
- Worship band members
